The only major reconsolidation planned for 2019 will be for the Case Law Digests: Family Law component of the Abridgment. We expect the reissue to comprise 30 volumes.

This reissue of the Family Law title provides an opportunity to significantly update and modernize the title, taking into account significant developments within the field since the last reconsolidation in 2010.
