

## 2020 ILTA Virtual Trivia GAME - OFFICIAL RULES

**NO PURCHASE NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED.**

**THESE ILTA Virtual Trivia GAME OFFICIAL RULES** contain the terms, covenants, conditions, and provisions upon which Thomson Reuters (“Thomson Reuters” or “Sponsor” or “we” or “us”) and you have agreed govern the game described below as a “Game”.

**PRIZES:** Ten (10) \$100 gift cards will be awarded from a choice of Amazon, Target, HomeDepot or GrubHub. Total prize value: \$1000

**ODDS OF WINNING:** Odds of winning depend on the number of Entrants.

If Sponsor ends the Game before the end of the Game Period, Sponsor may, in its discretion, determine winners via **the current Leaderboard list of top 10 players**.

Sponsor reserves the right to disqualify any Entrant it finds to be tampering with the entry process or operation of the game; to be acting in an unsportsmanlike or disruptive manner; or to have otherwise violated any of the Official Rules.

Sponsor reserves the right to substitute prizes of equal or greater value. No other substitution or transfer of Prizes is permitted.
