#### In law firms describing their cloud philosophy

- **35%** of law firms are considering cloud with every upgrade
- 33% are considering the cloud
- 21% are mostly in the cloud
- And only 11% are not yet comfortable with the cloud





42 legal profession organizations affected by ransomware published in cyber expert's database




Figure 2: Ransomware Attacks by Law Firm Size – Source: Tari Schreider Ransomware Attack Database Figure 1: Ransomware Attacks by Legal Organization– Source: Tari Schreider Ransomware Attack Database



### Cyber security THREATS

Firms have a long way to go to prevent cyber security threats

> Employees are their greatest risk

**Cyber Security Training** – only 46% of the law firms surveyed conduct cyber security training programs to protect against phishing attacks

**Business Continuity Plan** – only 40% of law firms indicated that their firm has a disaster recovery/business continuity plan

**Cyber Insurance Policies** – only 36% of U.S. law firms obtained cyber insurance policies in 2020. (But this is up from 33% in 2019)

### Cyber security TRANNC

Very few firms (5%) hold trainings at the recommended monthly cadence

Train your lawyers and business professionals on cyber threats

- Training is not a one-time event each year, have short monthly training sessions
- Have mock cybersecurity attacks
- Email pfishing
- Smishing
- Give prizes for the first 5 that recognize it
- Have mock calls saying from bank, fiduciary for fake emergency

- ROI on automation




### Summary KEY TAKE-AWAYS
