II. Submitting Articles to *Perspectives*

A. How, to Whom, and When to Submit

Submissions are accepted on a rolling basis, but generally, the deadlines are July for the fall/winter issue and January for the spring/summer issue.

B. Manuscript Form and Length

1. **Author Information.** Provide only your name, professional title, and institutional affiliation. Place this information immediately after the article's title, not in a footnote.
2. **Typeface and Margins.** Type in Times New Roman, 12-point font, **double**-spaced text with **1-inch** margins.
3. **Length.** Articles should run between 1,500 and 7,000 words. Longer articles may be considered but also may be shortened to fit available space.
4. **Footnotes.** Footnote lightly. Use footnotes, not endnotes. Identify notes in the text by superscript numbers.
5. **Citation Form.** Conform citations to academic format in the current edition of *The Bluebook* or the *ALWD Guide to Legal Citation*. In other words, use large and small capitals, when appropriate. Use italicizing, not underlining, when appropriate.
